- 1. All professors were excellent with their instruction. If clarification was ever required, responses were timely and helpful.
- 2. The program was amazing! Informative, and definitely put me in contanct wit

The quality of instruction was uneven based the quality of the instructor. In one class the instructor had her personal assistant grading papers and supplying feedback. I was not made aware of his scholarship nor do I know his credentials. It was frustrating when it appeared that the professor was off to multiple conferences while pawning off lectures and grading assignments to an assistant. If the class is not worth her time....is it worth mine?

I prefer having a professor who spoke native English. I feel that I missed out on not getting the full appreciation of the course due to the language barrier.

I completed the entire degree online and was impressed at how well the instructors and the program catered to this environment. Though there were a few exceptions, for the most part I did not feel disadvantaged by being unable to attend class in person. All of the professors are incredibly knowledgeable and have a real passion for the LIS field. When people ask me about the program, it is the enthusiasm and knowledge of the professors I generally bring up first.

- Most professors were able to make the online learning environment more than just self-directed

  5. learning. The use of small discussion groups, recorded lectures and videos about the upcoming weeks work created a space that was positive and successful for my learning.
- 6. Overall, with the exception of one course, the instruction was relevant and incredibly informative.
- 7. I enjoyed my classes and the instructors were knowledgeable and accommodating

The majority of the courses I took in the program had valuable content and were delivered with a great deal of instructor expertise. Particularly valuable courses for me were LIS 506 with Jianqiang Wang, LIS 571 & S71 & S7

Less useful courses for my personal situation were LIS 581 and LIS 518, but I still picked up a few tips/tidbits that were helpful.

- 9. All the professors had very thorough and in-depth knowledge of the subjects.
- 10. I feel i learned so much in the program.

- 11. Most professors provided excellent instruction. A couple did not.
- The LIS professors were excellent. They provided real world scenarios that help to prepare me for school librarianship and working with other educators and students.

- 1. All interaction with faculty was to a high standard of excellence and ease.
- Most of my interactions was positive. However, my advisor went on sabbatical and it was difficult trying to get in touch with her replacement. When I emailed him, he stated "I am not your advisor". I had to show him the email alerting me that he was in fact my new temporary advisor for him to actually respond to me. And you can guess how much help he was.
- Faculty went out of their way to make themselves available to students. My emails were always answered promptly and any problems or questions I had addressed respectfully.
- 4. All professors were willing to offer assistance with any questions that I had.
- 5. Overall the interactions were positive and instructors were supportive of learning.
- 6. Quick to respond to emails, and always willing work with me when I had issues.
- The LIS faculty I interacted with were: Battleson White, Wang, Brower, Albertson, Nesset, Hollister, and Bright. They were all wonderful to work with. After my first semester, I took advantage of asking around with my fellow students to see if they had recommendations for or against certain faculty, and I took this peer feedback into account.

- **9.** Please comment on the above question (8).
- Being an online student, interaction with other students was generally limited to group work. Outside of rare professional disagreements with project work, interaction was positive and enlightening.

It seems that 60% of my assignments were group related. Invariably one student would not respond to emails nor help in the group assignment. When I would bring my concern to my professors, as if

- they were reading it on an index card: "In the real world you are going to have situations were co-workers are not pulling their weight". My response would be...in the real world I would go to my supervisor and expect them to address the situation and not blow me off and make me do twice the amount of work.
- This is the only area I wish the program could expand on, but the limitations of the online

  3. environment make it difficult. The limited interactions I was able to have (discussion board, group work) were generally positive.
- 4. All discussions and group projects were positive experiences.
- Though I hate group projects, the professors keep the group members accountable for their part of the project and don't allow it to impact my grade.
- My experiences with fellow students ranged from neutral to highly positive. Although certain group project assignments were logistically painful at times, since many (most?) students also work full-time, I do value the peer relationships they helped foster. I found most students to be engaged, friendly, and intelligent.
- 7. Forum discussion posts and group-work are not effective pedagogical tools.
- 8. Some of the group projects were difficult as they did not necessarily lend themselves to group work, making interactions with fellow students strained at times.
- 9. Only really interacted with the in the projects or discussion postings.
- Group work is always a challenge because all individuals have differing work ethics, schedules, and availability to work on projects, but everyone I worked with interacted professionally.
- Being an online student, there was little interaction with other students. The few courses that required group work was beneficial.

Most fellow students were easy to work with. Some fellow students really drop the ball when working in groups.

# **25.** Do you have any suggestions for improvement?

- 1. Use more up to date technology for interaction between professors and students. Focus more on the strengths of online distance learning rather than try to make it more like campus learning.
- Please hire professors that have a vested interest in the program/students. From my view, it seems that some of the instructors are here for a resume booster and putting forth a minimal effort.
- I would like to see the course offerings include instruction geared more towards the specialized library environment. Business resources, Competitive Intelligence, law librarianship, etc.
- Offer more electives, mainly the ones that are listed on the concentrations page. There were no classes for the academic concentration or legal
- Some classes were difficult because the material was outdated and written by the professor. Possible update to material and additional texts.

The variety of electives for academic libraries/specialty and non-traditional libraries could be improved. Additionally, I was somewhat disappointed when certain advertised electives were

cancelled in multiple consecutive semesters.

- Another note: internships/special projects currently have a strangely stringent requirement that they be unpaid, unless a special petition is made. I assume this is an attempt to ensure that interns are doing more than fetching coffee, etc., but I urge the dept. to get rid of this "internships should be unpaid" stipulation. It is outdated and helps perpetuate the under-valuing of LIS work. Senior colleagues I have spoken to in the field have unanimously commented to me that they think students should be paid for their contributions to outside organizations (or, at minimum, have the tuition fees for internship credits be drastically reduced/waived).
- 7. Not doing group projects in courses where work has to be uniform to each other (database courses, specifically)
- 8. There should be an improvement on the interaction with online students.
- Some professors could use help in course organization/design, implementation of instruction, and how much reading is realistically going to be able to be absorbed in one week. Kawanna Bright,

  Brenda Battleson White, and Maria Muhlbauer were the best at this. Maybe they could do workshops for the other professors.
- I enjoyed the way LIS 505 was facilitated. When I took the course, I used Collaborate to " sit in" on the course. It was a great way to feel as though I was part of the class. It was my first experience with online learning. I wish I had other courses similar to it.
- 11. A more proactive advisement program and a graduation checklist.

I think that more courses should be offered for specific library types. It seemed as if the same classes were being offered each year and by the end you were running out of choices and you didn't really end up with a detailed education in any specific field. Most fields only had one course that only taught

12. the basics. For example, collection development, cataloging, medical libraries, etc. Also, with the courses being graduate level courses they should be more difficult and provide more in depth information. Most of my undergraduate courses were more difficult and more detailed than the courses in this program.
